

## **Terms and Conditions for Hybrid Race Simulation & Clinic – Paradise Edition**

### **1. General**

1.1 These Terms and Conditions (“T&Cs”) apply to all participants (“Participants”) of [**Hybrid Race Simulation & Clinic – Paradise Edition**] (“the Event”) organized by **RUN SG** (“the Organizer”).

1.2 By registering for and/or participating in the Event, all Participants agree to comply with these T&Cs.

### **2. Registration & Entry Fee**

2.1 Pre event registration is \$200. Registration is only confirmed upon full payment of the package fee. Details of full payment will be sent to participants in due time.

2.2 Package fees are non-refundable and non-transferable once full payment is made, except as required by law or at the sole discretion of the Organizer.

2.3 The Organizer reserves the right to reject any registration without providing reasons.

2.4 Fee does not include flight and land transfer to event site.

### **3. Eligibility**

3.1 Participants must meet the minimum age requirement of [16 years] on the day of the Event.

3.2 Minors must provide parental/guardian consent.

3.3 Participants must be in good health and physically fit to take part in the Event.

### **4. Health & Safety**

4.1 Participants take part at their own risk and are responsible for their own health, fitness, and equipment.

4.2 The Organizer may require a Participant to withdraw from the Event if deemed medically unfit to continue.

4.3 All Participants must follow safety instructions given by event officials, marshals, or medical staff.

### **5. Liability & Insurance**

5.1 The Organizer, sponsors, and partners shall not be liable for any injury, loss, damage, or expenses arising from participation, except where caused by proven negligence.

5.2 Participants are strongly advised to have personal accident and health insurance coverage.

5.3 Personal belongings are the responsibility of the Participant. The Organizer is not liable for loss or damage.

### **6. Event Changes & Cancellation**

6.1 The Organizer reserves the right to postpone, cancel, or modify the Event due to weather conditions, safety concerns, government regulations, or other unforeseen circumstances.

6.2 No refunds will be given in case of cancellation due to force majeure.

### **7. Code of Conduct**

7.1 Participants must respect fellow participants, officials, volunteers, and the general public.

7.2 Unsportsmanlike behavior, including cheating, abusive language, or misconduct, will result in disqualification.

7.3 Alcohol, drugs, or prohibited substances are strictly forbidden before and during participation.

## **8. Media & Data**

8.1 By participating, Participants grant the Organizer the right to use photographs, videos, and other recordings of the Event for promotional, marketing, and reporting purposes.

8.2 Personal data collected during registration will be used in accordance with applicable data protection laws.

## **9. Waiver & Indemnity**

9.1 Participants acknowledge the risks involved in the Event and voluntarily assume all such risks.

9.2 Participants agree to release, discharge, and indemnify the Organizer, sponsors, and partners from any claims or liabilities arising from participation.

## **10. Governing Law**

10.1 These T&Cs shall be governed by and construed in accordance with the laws of Singapore

10.2 Any disputes shall be subject to the exclusive jurisdiction of the courts of Singapore.
